- Any product dispensed for the purpose of appetite suppression or weight loss.
- Any product for which the primary use is a source of nutrition, nutritional supplements, or dietary management of disease, and prescription medical food products even when used for the treatment of Sickness or Injury, except Medical Foods for treatment of Inherited Enzymatic Disorders for which a participating Physician has issued a written, oral or electronic prescription for home use.
